# **BASIC USES**

For installation of vinyl composition tiles.

# **COMPOSITION AND MATERIALS**

A synthetic light-coloured, high-strength latex/resin emulsion which develops a bond of exceptionally high strength when used properly. It contains no solvent, hazardous ingredients, or carcinogenic materials as defined by WHMIS or OSHA regulations.

# **LIMITATIONS**

- Not recommended for PVC or rubber tile. (Use Flextech 710 Premium Universal Flooring Adhesive)
- Protect from freezing in transit and storage.
- Do not use at temperatures below 5°C (40°F) or above 40°C (104°F)
- For interior installation only.
- Concrete floors must be completely cured (28 days). Do not installed
  when moisture vapor emission (MVER) exceeds 2.25 kg per 92.9m²
  (5 lbs. per 1,000 sq. ft.) per 24 hrs, when using the anhydrous
  calcium chloride test (ASTM F1869). Moisture Test Kits are available
  at Flextile and its distributors.

Do not use over gypsum base surfaces.

## **INSTALLATION**

SUITABLE SUBSTRATES

When properly prepared as described in preparatory work, suitable substrate includes:

- Well-cured concrete and smooth cementitious surfaces; on, above or below grade; free from excessive moisture or alkali.
- Approved plywood on suspended floors.
- · Latex Portland cement based underlayment
- Existing well-bonded resilient flooring.

# PREPARATORY WORK

Surfaces must be sound, even, dry and free of grease, oil, dirt, paint, curing compounds or sealers, or other foreign matter. Nail down any loose edges or loose areas of subfloor and sand and smooth all raised edges. Fill surface cracks or depressions with Flextile Patch and sand smooth and vacuum to remove dust. Fill and level surfaces with Flextile 59 FlexFlo or 5900 FlexFlo Plus Self-Leveling Underlayments following product installation instructions, and sand smooth and vacuum to remove dust.

Install plywood over tongue and grove flooring or parquet to prevent surface pattern from "telegraphing" through the new floor finish. Adhesive, flooring and surface must be at 15°C (60°F) or higher.

#### **APPLICATION**

Refer to installation instructions of the flooring manufacturer. Pour a small quantity of adhesive on the floor and with a firm hand, spread evenly using a trowel having 1/16"(1.6mm) V-notches on 1/16"(1.6mm) centres. Before installing tile, let adhesive dry until it is clear and tacky but does not transfer to the finger when touched. Tile may be installed up to 24 hours after application of adhesive. Position tile carefully because tile cannot easily be moved on dry adhesive. To ensure overall contact, roll with a 100lb. 3-section roller within 24 hours of installation. Clean adhesive from face of tile while still wet with a damp cloth.

## **PROTECTION**

Do not allow traffic for 24 hours after installation. Do not allow rolling load traffic for at least 72 hours after installation to allow setting and drying of the adhesive.

## **SAFETY**

Refer to Flextile Material Safety Data Sheet for health and safety information.
